The undersigned is directed to say that the Government has no Objection to the establishment of a new B.Ed. College in the name of "Surendra Lal Das Teachers' Training College" at P.O. Anandanagar, Bally, Dist. Howrah, strictly on self-financing basis subject to fulfilment of necessary terms and conditions issued/amended from time to time in this behalf by the University concerned/State Government/any other regulatory authority having jurisdiction in the matter with effect from the current academic session.

2. It may please be noted that the said B.Ed. College will remain outside the purview of West Bengal Colleges (payment of salaries) Act, 1978 and in no circumstances the Government will take the responsibility of the salaries of the Teaching/Non-teaching staff as well as other expenditures either in full or in part.

3. This 'No Objection Certificate' is issued only on condition that the required amount for different funds as follows will be deposited in the bank by the proposed college authority as per their Declaration prior to the beginning of the next academic session under intimation to this department :

- i) Reserve Fund
₹. 10,00,000/- (Rupees ten lakhs) only (₹. 5,00,000/- as NCTE
Reinvestment Fund and ₹. 5,00,000/- as General Reserve Fund separately)
- ii) Operational Fund in C.A.
₹. 7,50,000/- (Rupees seven lakh fifty thousand) only.
- iii) Building Fund
At least ₹. 15,00,000/- (Rupees fifteen lakhs) only.
