In terms of the resolutions of the Syndicate of the University of Calcutta dtd. 08.11.2005 (item no.21) and the undertaking submitted by The Secretary, Surendralal Das Teachers Training College, (B.Ed, Self-Financed) in response to the University letter no.1022/UCAC/05 dtd.10.11.2005 for considering the following course in one(1) year B.Ed. degree (self-financing).

Course	Intake	Session
B.Ed	100	2005-2006

Surendralal Das Teachers Training College, (B.Ed, Self-Financed) is hereby accorded the provisional affiliation for three(3) years subject to the fulfillment of the following terms and conditions. Any infringement / contravention / non-compliance of these conditions may lead to withdrawal of the affiliation.

1. The number of working days as mentioned in the proposal should be increased to 150 from 120 days. It is to be ensured that six(6) hours for holding classes and other activities are made available everyday and the class routine is prepared accordingly (a copy to be submitted duly.)

2. Resolution of the school Governing Body on the agreement with the Organising Committee is to be submitted to the Secretary, Faculty of Education. All other documents including the copy of the proposed and sanctioned building plan and land acquisition deed are also to be submitted.

3. The "Organising Committee" has to be replaced by a "Governing Body" which is to be specified by (i) composition, (ii) Office bearers, (iii) Names of the Office bearers and members, (iv) their mode of election/selection/nomination as per prevailing rules and norms of the University and/ or Government of West Bengal.

4. The said Governing Body will prepare in writing all regulations for running the college including (i) selection of students, (ii) appointment of Teachers by a duly constituted selection Committee with Vice-Chancellor's nominee and other members, (iii) financial matters, (iv) any other matter related to the vital functioning of the college for which Governing Body resolutions are essential.
5. Necessary furniture, books, laboratory equipments are to be arranged immediately. The existing facilities being insufficient these are to be provided to the students from the very beginning. A psychology laboratory is to be established and the college should arrange its own education technology laboratory.
6. The college should keep contact with the P.G. Board of Studies in Education, Calcutta University for the all academic matters.
7. The Surendralal Das Teachers Training College, (B.Ed, Self-Financed) should abide by the Statutes and Ordinances related to Calcutta University Act and those enforced from time to time. UGC and NCTE norms and order of Government of West Bengal as may be applicable for self financing colleges should be duly obeyed. Approval of the NCTE has to be obtained duly.
9. Admission of students will be made strictly on merit basis.
10. Staff structure should be changed from the proposed one. There should be seven (7) full time teachers and one (1) full time Principal. Non-teaching staff should include one Librarian. Existing staff pattern should be replaced and appointed accordingly.
11. Methods papers and special papers may be allowed to be offered by the college as prayed for in the application.
12. A report of progress about the terms and conditions mentioned above should be furnished to the undersigned within six (6) months from the commencement of the college.
13. The conditions as laid down in the Para 3 of the 'No Objection Certificate' issued by the Higher Education Department, Government of West Bengal under no. 636-Edn(C.S)/4C-45/05 dtd. 13.09.2005 must be complied with.
